AT A TIME WHEN MANY PEOPLE WITH DISABILITIES WERE INSITITUTIONALIZED, THE ORGANIZATION PROVIDED A PLACE WHERE PEOPLE COULD LEARN JOB SKILLS AND EXPERIENCE THE SENSE OF PRIDE THAT COMES FROM EARNING A PAYCHECK.
